Applications are invited from the suitable and eligible officers for filling up two post of **Upper Division Clerk (Group-'C' Non-Gazetted)** in Ganga Flood Control Commission, a subordinate office under Ministry of Water Resources, River Development and Ganga Rejuvenation, Govt. of India, Patna on deputation basis in the scale of PB-I, Rs. 5200-20200 + Grade Pay of Rs. 2400/- (Pay Matrix Level-4 in 7th CPC) amongst officers of the Central Government or State Government or Union Territories or Autonomous Bodies:-

- (a) (i) Holding analogous post on regular basis; or
- (ii) Lower Division Clerk with eight years' regular service in Pay Band-1, Rs. 5200-20200 plus Grade Pay of Rs. 1900/- (Pay Matrix Level-2 in 7th CPC) or equivalent in the parent cadre or Department.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed 03 (three) years.

Note 3: The maximum age-limit for appointment by deputation shall "not exceeding 56 years".

Note 4: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 the date from which the revised pay structure based on the Sixth CPC recommendations have been extended, shall be deemed to be service rendered in the corresponding Grade Pay or Pay Scale extended based on the recommendations of the Pay Commission except where there has been merger of more than pre-revised scale of pay into one grade with a common Grade Pay or Pay Scale and where this benefit will extend only for the post for which that Grade Pay or Pay Scale is the normal replacement grade without any upgradation.

The candidates who fulfill the eligibility conditions as stipulated above may send their application in the prescribed Proforma (Annexure-I) through proper channel along with (i) **APAR dossiers for the last five years (Photocopies of the APAR duly attested by the officer not below the rank of Under Secretary)** (ii) **Vigilance Clearance Certificate** (iii) **Integrity Certificate duly signed by the Competent Authority** and (iv) **No major/minor penalties certificate during the last 10 years, if any, within 60 days** from the date of publication of the advertisement in the Employment News. The application received on or after closing date of receipt of the application will not be entertained in any circumstances.
